A. Introduction

- 1. PU Prime is a business name of PU Prime (PTY) Ltd (the "Company", "us", "we", "our", "ours" or "ourselves" as appropriate), an authorised Financial Service Provider ("FSP") registered and regulated by the Financial Sector Conduct Authority ("FSCA") of South Africa under licence number 52218 and located at 37 Harley Street Ferndale, Randburg 2149 Gauteng.
- 2. The "Xmas Make A Wish Terms and Conditions" is an integral part of the "PU Prime Terms and Conditions" and provisions set herein are considered as an annex of all "PU Prime Terms and Conditions" and they should be read in conjunction.

B. Conditions of Eligibility

- 1. Subject to, and without prejudice to, all other Terms and Conditions, the offer is available to PU Prime's Clients who have satisfied the Eligibility Criteria for the offer ("Eligible Clients") as set out in the sections following hereinafter.
- 2. The "Xmas Make A Wish" may be offered by PU Prime from time to time to clients who open real trading accounts (meaning not demo) with PU Prime, in cases where such clients are referred to PU Prime via specific websites and/or social network sites in the context of certain specific promotions, and/or surveys that PU Prime may be running from time to time on such specific websites and/or social network sites.

unless the context otherwise requires, shall mean to include any person or entity bearing a relationship with any participant in the "Xmas Make A Wish", including, without limitation:

- a) family members, such as brothers, sisters, spouses, ancestors, lineal descendants and collateral descendants;
- b) person or entity, whom any participant in the "Xmas Make A Wish", directly or indirectly through one or more intermediaries, controls, or whom, directly or indirectly, through one or more intermediaries, is controlled by, or is under common control with any participant in the "Xmas Make A Wish"; for purposes of this definition, the term "control" (including, with correlative meaning, the terms "controlled by" and "under common control with"), as used with respect to any participant in the "Xmas Make A Wish", shall mean the possession, directly or indirectly through one or more intermediaries, of the power to direct or cause the direction of management policies of such person or entity, whether through ownership of voting securities or otherwise.
- 6. Similarly, persons associated in any manner whatsoever with PU Prime and/or with the specific websites and/or social network sites on which PU Prime may be running from time-to-time certain specific promotions, contests and/or surveys, in the context of which access to the "Xmas Make A Wish" is offered, are not allowed to participate in the offer.
